## EXPERIENCE

### **Secured Dismissal of \$35 Million Claim for Infringement**

Successfully defended a corporation against allegations of patent infringement and copyright infringement in federal court, resulting in dismissal of all counts.

### **Dismissal for Public Utility Owner, with Sanctions Against Plaintiff**

Represented a public utility owner in a federal court case involving a complex commercial transaction, securing a dismissal with prejudice against a plaintiff resulting from our motion for terminating sanctions over the plaintiff's various discovery violations.

### **Dismissal of \$1 Million Damages Claim and Attorney Fees Award**

In this interpleader action in a rural venue against a sympathetic plaintiff, represented a regional bank in defeating a counterclaim seeking over \$1 million in damages by obtaining a total dismissal with prejudice in our favor, which included an attorney fees award.

### **Successfully Defended Client in Wrongful Death Case**

Conducted the investigation and successfully represented a national fast-food delivery company in a high-profile wrongful death case stemming from a shooting that occurred at one of the client's restaurants.

### **Favorable Settlement for Client in Environmental Violations Case**

The state of Missouri sued our client for environmental regulatory violations and illegal hazardous waste dumping, seeking nearly \$3 million to settle the case. Developed evidence through an internal investigation that directly contradicted the state's primary evidence, resulting in a favorable settlement of only \$10,000 for our client.
